INVITATION FOR TENDERS

1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in **PPRA Website** dated **30th August, 2018**.
2. The Dar es Salaam City Council has set aside funds for the operation during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Proposed City Social hall and 19 shops to be built at Drimp Botanic Garden in Dar es Salaam**.
3. The Dar es Salaam City Council now invites sealed tenders from eligible "National" contractors registered in class five (5) and above for as indicated in the table below:-

Tendering will be conducted through the National Competitive Tendering a procedure specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2013 – Government Notice No. 446 and is open to National Tenderers only as defined in the Regulations unless otherwise stated in the **Tender Data Sheet**.

Box 9084 Dar es Salaam ground floor PMU's Office from 9.00am to 3.00pm on Mondays to Fridays inclusive except on public holidays.

4. All tenders must be accompanied by a tender securing declaration in the format provided in the tendering documents.
5. All tenders in one original plus two (2) copies, properly filled in, and enclosed in plain envelopes must be delivered to the address below at or before **14:00 pm on 24th October, 2018**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend the opening at the Board Room, 2nd floor - City Hall at the junction of Morogoro Road/Sokoine Drive.
6. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the Dar es Salaam City Council, City Hall, Board Room 2nd Floor at the junction of Morogoro Road and Sokoine Drive
7. Late tenders, portion of tenders, electronic tenders, and tenders not received, tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstance.
