Purpose of the project:

The purpose of this assignment is to provide technical assistance to the Government of Tanzania for the procurement services of the (feasibility) studies for the Dar es Salaam integrated waste project.

Goals and deliverables

The assignment can be divided into three parts:

1. Procurement assistance in the run up to and during the Request for Proposal phase;
2. Advice and technical assistance during the Contract Negotiating phase.
3. Contract negotiations

For the overall assignment, it is estimated that the work will take place for about 40% at your own location and 60% in Dar es Salaam or Dodoma.

The assignment focuses on procurement assistance for the studies for the Dar es Salaam integrated waste project. The procurement expert will work closely together with DCC and other government parties involved in the Evaluation committee (PORALG, WB, VP office). The procurement expert works on behalf of RVO and will advise RVO.

Required Skills/ Experience

The company or companies (in case of an consortium) must meet the following requirements:

- The Lead Consultant must have at least 8 years of demonstrable knowledge of and experience with international procurement, procurement guidance and contract negotiation support;
- Work experience in a comparable context and assignments i.e. feasibility studies for infrastructure projects, in a developing country (DAC List of ODA Recipients) is desirable.
- Travel and delivery on location in Dar es Salaam or Dodoma is part of the assignment;
- The Consultant must have experience with procurement principles and requirements according to World Bank and OECD (or similar) standard bidding documents and procedures.
- Knowledge of Swahili is beneficial but not required.

Application

Based on the market orientation, RVO can decide to start a procurement procedure. Interested companies / consultants can be invited to this procedure. Your response to this market orientation does not mean you have the right to be invited to this purchasing procedure. When multiple companies / consultants respond, there can be a random supplier selection.
